



What is needed to complete the application process:

1. User Specific Email Account- emails cannot be shared. Email addresses must be unique by agent. If you are an Agency owner as well as a participating Agent, you will need unique email addresses as an Agency and an Agent.
2. Digital Copies of:
 - a. Errors and Omissions Policy
 - b. W-9
 - c. Signed Producer Contract(s)
3. License Information

Completing the Application of Appointment

Once a Friday Health Plans Admin or an Agency has entered an applicant into the Friday Health Plans Broker Appointment platform, an email notification will be sent to the applicant's email. The email will come from noreplyjob@evolvenxt.com. Depending on your organization's email security, this email may end up in a junk or spam email box- be sure to check these locations if you have trouble finding it.

NOTE: EvolveNXT is the platform Friday is using to help simplify the appointment process.

You will also receive a separate email from Friday Health Plans with your state-specific Producer Agreements. These will need to be uploaded during the application process.

1. Open the Friday Health Plans Contracts and Application for Appointment- Action Required email.
2. Click on the URL located in the middle of the message.
3. Using the **login email address** and **Password**, login to the portal.
4. You will be taken to Onboarding Cases where you will begin your application.
5. Before beginning the application, verify the information under Onboarding Name, Year, NPN, States and Upline Level has been entered correctly.
 - a. The year should be the year that the application is being submitted in. For example, if an application is being sent on 8/27/2020 the year should be 2020.
 - b. If you notice that any of the information is entered incorrectly, contact brokers@fridayhealthplans.com or 844-270-7075 to correct this information.

6. Click Start.
7. Contact Info
 - a. Verify any pre-filled personal information.
 - b. Enter all information required in the blank boxes.
 - c. Click on the blue "Check NPN" button. This will validate the NPN that was entered.
 - d. Complete the Primary Address Information.
 - e. Click Continue.
8. Additional Info
 - a. Complete the Background Questions by answering "Yes" or "No".
 - b. For any questions answered "Yes", please enter a detailed explanation of the circumstances.
9. License Info



- a. Review the NIPR response; no action is needed by the applicant at this point.
 - b. Click Continue.
10. Documents
- a. Upload documents for Friday Health Plans review.
 - b. E&O
 - i. Enter the Carrier Name.
 - ii. Enter the Start Date of your policy.
 - iii. Enter the End date of your policy.
 - iv. Enter the policy coverage amount (limits).
 - v. Click Browse.
 - vi. Select the file that you wish to upload.
 - vii. Click Upload.
 - c. W-9
 - i. Click Browse.
 - ii. Select the completed W-9 file that you wish to upload.
 - iii. Click Upload.
 - d. Contract (state-specific Producer Agreements)
 - i. Click Browse.
 - ii. Select the file(s) that you wish to upload.
 - iii. Click Upload.
 - e. Click Continue.
11. Submit
- a. Review the Attestation.
 - b. Check the two boxes below the attestation.
 - c. Sign your name in the signature capture box.
 - d. Click Submit.
12. Once submitted, you will have the option to download and save / print a copy of your signed attestation.
